	SUBJECT: Visiting Regulations

 PURPOSE AND SCOPE: This institution supplement outlines local visiting procedures for the FCI and FPC Talladega, Alabama, in accordance with Program Statement 5267.09 <u>Visiting</u> <u>Regulations</u>, dated December 10, 2015. This institution supplement must be read in conjunction with Program Statement 5267.09 for a clear understanding of policy.

- 4. **PROCEDURES:** All activities regarding the arranging and supervision of inmate, detainee, and holdover visitation will, except under unusual circumstances, be conducted during normal staff duty hours.

## a. <u>VISITING FACILITIES:</u>

- (1) <u>FCI</u>: Social and legal visits for general population inmates at the FCI will be conducted in the institution visiting room. It is the Captain's responsibility to ensure the visiting room is properly staffed, furnished, aesthetically maintained, and ensures a secure and orderly atmosphere for inmates and their visitors.
- (2) <u>FPC</u>: All inmate visits will be conducted in the designated visiting area solely for that purpose. Visitors are to enter and leave the visiting room through the main door only. Inmates must enter and leave through the designated shakedown room. Visitors are not allowed to linger in the parking lot in front of the administration building. Children of visitors are permitted to play only in the designated area under parental supervision. Once a visitor has departed the visiting room, their visit is considered concluded and they may not re-enter the visiting room for that day.

FCI/FPC Talladega is a designated as a <u>NO SMOKING</u> facility. Visitors will not be allowed to bring tobacco products into the institution.

Parents and guardians are responsible for the behavior and actions of their children. Lack of parental supervision may result in removal from the visiting list or visiting area.

## b. <u>WEB VISITING PROGRAM</u>

In establishing inmate visiting procedures at Federal Bureau of Prisons facilities, certain restrictions and controls governing visiting regulations must be adhered to. The Warden has the authority to exercise and implement procedures that will include and permit visiting privileges for the inmate(s) and his visitor(s) consistent with maintaining good order and security of the institution.

These procedures will allow the inmate's visiting list to be forwarded to the next institution in the event they are transferred. The existing visiting list information, i.e. visitor's photos, will be retained in order to maintain a permanent record of visitors which is required by the institution and to meet program objectives.

When the computer system is not functioning or inoperative, staff will notify the Operations Lieutenant/Institutional Duty Officer. The Unit Counselors are responsible for maintaining a hard copy of the inmate's approved visiting list at the Front Entrance. In the event, the inmate does not have a hard copy present, staff will contact the inmate's Unit Team for a copy. If there is no Unit Team available, the Institutional Duty Officer/Operations be notified.

<u>FCI Visiting Hours</u>: Visiting hours are from 8:30 a.m. to 3:00 p.m. Saturday Sunday and Monday.

<u>FPC Visiting Hours:</u> Visiting hours are from 8:30 a.m. to 3:00 p.m. Saturday Sunday and Monday.

NOTE: Should inmates be present in the visiting room during official counts or institutional lockdown accountability census checks, they will be counted in the visiting room, unless directed otherwise.

## d. <u>FREQUENCY/NUMBER OF VISITORS:</u>

<u>FPC and FCI</u>: Inmates will be allowed an unlimited number of visits. However, the number of visitors will be limited to five (5) adult visits, not to include children. When overcrowding occurs in the visiting room, the Institution Duty Officer and/or the Operations Lieutenant are authorized to terminate some visits in order to make room for arriving and/or waiting visitors. No visitor will be asked to leave who has not visited for at least two hours. The decision to terminate visits must be based on good judgement to include consideration of the following:

- (1) Distance traveled by the visitor and frequency of the visits by this visitor.
- (2) Health, age, and physical conditions that limit ability to travel by the visitor.

The Visiting Room Officers will be responsible to monitor the total compliment of visitors and inmates in the visiting room to ensure a safe environment. The maximum capacity for the FCI is 185. The maximum capacity for the FPC Visiting Rooms is 150, respectively.

## e. <u>GENERAL POPULATION</u>

(1) <u>Regular Visitors</u>

Each inmate, holdover, and detainee will, upon his arrival at the institution, receive a copy of the inmate handbook during the intake screening process. The handbook will contain the information detailing inmate visiting rules and procedures. Each newly committed inmate, upon his arrival and assignment to his designated housing unit, will be instructed by his counselor to submit a list of immediate family members for placement on his visiting list. For the purpose of this documentation, immediate family members consist of mother, father, step-parents, foster parents, brothers and sisters, spouse, and children. An inmates spouse can include a common-law relationship.

It is the inmate's responsibility to provide his assigned counselor the names of any additional persons he wishes to add to his visiting list (Attachment A). The inmate will be given the necessary Visitor Information forms (BP-629) to mail

to those prospective visitors. The visitors will complete the forms and mail them directly to the counselor. Inmates must emphasize to the prospective visitor that all elements of the form must be completed or it may be rejected. The counselor will then voucher the visitors and forward the completed forms to the respective unit manager for approval. Staff shall notify the inmate of each approval or disapproval of a requested person for his visiting list. Staff will provide the inmate the necessary visiting guideline forms (Attachment B) to mail to his visitor(s). It is the responsibility of the inmate to ensure proposed visitors receive this documentation. The visiting files of those inmates redesignated from another Bureau facility will be reviewed by the assigned unit team staff to ensure the proper clearances are in place. No further visitor approval will be required unless the inmate requests to add another visitor to his visiting list. An inmates visiting list may be amended at any time in accordance with the procedures of this supplement.

Children under the age of 16 may not visit unless accompanied by a responsible adult. Visitors who are 16 or 17 years of age and not accompanied by a parent, legal guardian, or immediate family member at least 18 years of age must have the written approval of a parent, legal guardian, or immediate family member at least 18 years of age prior to visitation. (As outlined in P.S. 5267.09)

The visiting privilege shall ordinarily be extended to friends and associates having an established relationship prior to confinement, unless such visits could reasonably create a threat to the security and good order of the institution. Exceptions to the prior relationship rule may be made, at any time, particularly for inmates without other visitors, when it is shown the proposed visitor is reliable and poses no threat to the security or good order of the institution.

<u>Disapproving Proposed Visitors</u>: If the background information reveals that visitation privileges for a proposed visitor would present security concerns or disrupt the orderly running of the institution, the Warden may deny visiting privileges. Documentation reflecting this decision should be maintained in section 2 of the Privacy Folder in the Inmate Central File. If such a denial is made, the Unit Team will notify the inmate.

When little or no information is available on the inmate's potential visitor, visiting may be denied pending receipt and review of necessary information, including information which is available about the inmate and/or the inmate's offense, including alleged offenses.

Potential visitors with criminal backgrounds and/or felony convictions must be approved by the Warden.

(2) <u>Special Visits</u>:

Requests for special visits are to be presented to the respective unit manager in

writing, stating the purpose of the visit, expected duration of the visit, etc. The case manager will verify the information and need for the special visit and prepare a written justification for the visit. The proposal will be submitted to the unit manager for approval. If approved, copies will be distributed to the AW (P), Captain, operations lieutenants, control center, front entrance, visiting file, and the inmate's central file.

Except for unusual circumstances, all special visits will be scheduled during normal visiting hours. When special visits are not during normal visiting hours, a member of the inmate's unit team will supervise the visit.

## (3) <u>Attorney Visits</u>

Requests for attorney visits are made directly to the respective case manager who prepares an appropriate memorandum for the unit manager's approval. The memorandum must include the inmate's full name, register number, attorney's name, date and time of visit, and name of staff member designated to supervise the visit in the inmate visiting room. Attorney visits for inmates assigned to Alpha Unit will be conducted in the visiting room.

Distribution of this memorandum is the same as special visits above. When attorney visits are not conducted during normal visiting hours, a member of the inmate's unit team will supervise the visit.

(4) <u>Pastoral Visits</u>:

Pastoral visits will be approved by the Supervisory Chaplain. Both the clergy person and the inmate must submit a request to the Chaplain in writing. The Chaplain will verify the clergy person and run an NCIC check. All pastoral visits will be held in the visiting room during normal visiting periods. An inmate may have only one clergy person on his visiting list. A clergy person who has been convicted of a felony will not be allowed to visit without the written approval of the Warden.

## f. <u>ALPHA B UNIT VISITING</u>:

1. The following procedures will be utilized regarding non-contact visiting for inmates housed in the Special Housing Unit, at FCI Talladega. Special Housing Unit visits, must be approved in advance by the Unit Team and Captain. Inmates will provide Unit Team staff with visitor information in a timely manner and expect at least (two) 2 weeks for processing. Visits will take place on Mondays only. SHU visitors will not be processed after 1:00 p.m. SHU visits will be limited to (two) 2 hours. No more than (two) 2 visitors will be allowed to visit each inmate. Inmates will be limited to two (2) hours of visiting a month. The inmates will remain in handcuffs, leg irons and a belly chain during the visit. Inmates will be secured in the non-contact room throughout the visit, under direct supervision of an officer. When FCI Talladega is in Covid-19 Matrix Red, there will be no Special Housing Unit visits. In the event there would be multiple SHU visits scheduled, SHU staff will ensure the room is properly cleaned and sanitized in between each use.

The visitor/visitors for the SHU inmate would be processed in at the scheduled time, adhering to the same rules and regulations. When the visitor/visitors enter the visiting room, they will be placed in the video monitor room, and the Visitation #1 officer will contact SHU and notify SHU staff. SHU staff will then place the inmate in the Alpha center area holding/Video Conference cell, and the SHU inmate would visit via video Tele-conference. A written copy of the approved visit will be provided to the Lieutenants' Office, Control Center, Front Entrance, and SHU staff. At no time, will a visitor show up at the institution and visit a SHU inmate without proper approval and a signed memorandum.

2. FCI Talladega does not have a specific facility designed for the conduct of noncontact visits. In the event that a specific case requires a non-contact visit, procedures for the required visit will be developed and distributed via memorandum on a situation specific basis.

3. Holdovers are not committed to general population housing units. Requests for visitation for inmates on holdover status will follow the same restrictions as those inmates housed in Alpha-B (SHU) and be limited to immediate family members.

# g. <u>COMMUNITY HOSPITAL PATIENTS</u>

(1) Visits for inmates hospitalized in the community will be determined by the Warden. If a visit is approved, it will be limited to immediate family only. All visits will be subject to the general visiting policy of the hospital. An approved visiting list will be forwarded to escorting staff.

Should the visit be denied due to the inmate suffering from an infectious disease, psychotic or emotional episode, or other condition which makes a visit inadvisable, the inmate's case manager will contact the visitor(s) and carefully and sensitively explain the reason for denying the visit to the visitor(s). The Health Services Administrator will then prepare a memorandum concerning the denial of the visit to be forwarded to the inmates housing unit for placement in the inmate's central file.

# h. <u>RECORD OF VISITORS</u>

The front entrance officer will ensure each visitor signs the inmate visitors log (Attachment C) when entering the institution and upon departure. At the end of the visiting day, the completed a Notification to Visitor forms will be forwarded to the Captains office for filing.

## i. VISITING ROOM CONDUCT AND APPROPRIATE DRESS:

- (1) Visitors will be allowed to bring only a small clear change purse (Requirement #23), three (3) diapers, clear ZIP LOCK bag of baby wipes, two (2) baby bottles with contents, and two (2) small sealed containers of baby food (no glass containers). Baby bottles will be mixed in the present of the Visiting Room OIC before consumption. No strollers, diaper bags, or baby carriers will be allowed. All other items will be stored in the lockers provided or in the visitor's vehicle. Keys to these lockers will be issued using Attachment D. No purses, watches, wallets, pens, pencils, writing paper, makeup, photos, toys, books, etc. will be allowed in the visiting room.
  - Paper currency, in denominations of \$5.00 or less, and coins may be brought into the visiting room by visitors. The total amount of money brought into the visiting room may not exceed \$20.00 per person.

Visitors will be allowed to take prescription drugs into the visiting room if they are needed; such drugs will be maintained by the Visiting Room Officer. Visitors in wheelchairs, using walkers or canes, will use institution wheelchairs, walkers, and canes. If these items are not available for use by the visitor, a thorough search of the wheelchair, walker, or cane will be conducted, and the Operations Lieutenant will be notified before the visitor enters the institution.

- (2) The front entrance officer will determine the visitor is not in possession of alcohol, narcotics, firearms, ammunition, or other contraband by verbally questioning the visitors. The visitor will then sign the required "Notification to Visitor" form, the visitor log, and present satisfactory identification such as a valid driver's license (with picture) or any government photo identification. If photo identification cannot be made of a person over 16 years of age, that person will not be allowed to visit the inmate.
- (3) Inmates are permitted a handshake, hug, and kiss at the beginning and at the end of the visit. Inmates will be allowed to hold babies and children under the age of two. <u>No</u> other physical contact will be allowed. Violations of the personal contact policy may be cause for termination of the visit and removal of the visitor from the inmate's visiting list. Inmates will sit across from their visitor. Other than holding a child under the age of two, visitors will not be allowed to sit anywhere other than across from the inmate.
- (4) Appropriate dress is required for inmates and visitors. Inmates must wear issued institution khaki clothing (no mixed colors) with belt, underwear, socks, and shoes. Upon entering the visitation search room, inmates will remove their personal or issued footwear. Institutional Crocs will be provided for the inmates to wear during visitation. Visitors will not be permitted to wear open toe shoes, barefoot, wear see-through clothing, halter tops, spandex pants or tops, tight form fitting clothing, strapless, sleeveless, or spaghetti strap dresses/tops.

Skirts or dresses with no splits, the length of all dresses must come to the top of the knee. Shorts may be worn by visitors in the visiting room, if they are knee length or do not come more than 1 inch above the knee. Shirts must not be revealing or provocative. No camouflage, khaki, or dark green clothing will be worn. No hats or head wear unless for religious or medical reasons. No jogging suits or sweat suit attire. Children under 10 years of age may wear shorts providing they are within the framework of good taste.

- (5) Visitors will not leave any form of money or any other item with the officer in charge or with the inmate. Money for inmates must be mailed to the centralized collection facility (Lockbox Program) in Des Moines, Iowa. Hobby craft items will not be given to inmates or visitors. Inmates will not be allowed to leave the visiting room with any monies or any other item provided by the visitor. If an inmate attempts to take money out of the visiting room, it will be confiscated by the visiting room officers, and an incident report completed.
- (6) Staff may require a visitor to submit to a personal search, including a search of any items of personal property, as a condition of allowing or continuing a visit.
- (7) Vending machines are available for use by the visitors. Visitors may purchase food items for the inmates. No food items or liquids (except for baby bottles and baby food) will be allowed to be brought into the visiting room by the visitor(s).
- (8) Inmates will be pat searched (visually searched on a random basis) upon entering the visiting room. All inmates will be visually searched upon the completion of the visit. Inmates will be randomly selected by the Operations Lieutenant to be processed through the Secure Pass system in R&D. The inmates processed through this system will be documented in the Lieutenant's log. The only items an inmate may bring into the visiting room will be: prescription glasses with case, one comb, wedding band, and inmate account card, and field jacket if needed (to be stored in the search room). An inventory will be prepared upon the inmate's entry into the visiting room (Attachment E). The inmate will be instructed to return all unauthorized items to his unit. Nothing will be stored in the search room except the above mentioned authorized items. Necessary legal papers will be allowed only during a visit with an attorney, paralegal, or law student.
- (9) All inmates entering the visiting room must be identified with a photograph. Inmates will bring their inmate account cards to the visiting room for identification. Any inmate reporting to the visiting room without their inmate account card will be denied entry. All inmates exiting the visiting room will again be identified with a photograph (inmate account card).
- (10) The visiting room play area for children is equipped with a TV and reading books for use by the visitors and children. Children will be supervised by their parent or adult visitor while in the play area. When not in the play area, children will be with their parents or visitor. There will be no running and throwing of

items in the visiting room. At no time will an inmate be allowed in the children's play area.

- (11) Tables and chairs will not be moved by the inmate or the visitors. Violations of this may be cause for termination of the visit.
- (13) Visiting rules and regulations, in Spanish and English, will be posted in the visiting room where they are accessible and easily read by staff, visitors, and inmates.
- (14) Any inmate using the restroom must be escorted and remain under constant visual staff supervision.
- j. <u>VISITING REGULATIONS REGARDING PETS</u>: Visitors are precluded from bringing any animals on institutional grounds, except for dogs that assist persons with disabilities. In this circumstance, the visitor must provide staff with certification that the dog is trained for that purpose.

## k. <u>PENALTY FOR VIOLATION OF VISITING REGULATIONS</u>:

1) <u>Visit Terminations</u>: The visiting room Officer-In-Charge (OIC) is to ensure visits are conducted in a quiet, orderly and dignified manner. Overall, he/she is responsible for the visiting room operations. The visiting room OIC will ensure that no one disrupts the good order of the visiting room. The OIC will contact the Operations Lieutenant/Institutional Duty Officer before terminating a visit. If a visitor becomes disruptive, he/she must immediately contact the Operations Lieutenant or Duty Officer. This also pertains to legal or official visitors. The decision to further limit or terminate a visit for reasons of improper conduct by an inmate or visitors can be made by the Operations Lieutenant or Duty Officer.

## 1. <u>WALSH ACT REQUIREMENTS</u>:

The Unit Team will evaluate all inmates on their caseload and all incoming inmates to determine if they have an inmate who has been convicted of a sex offense involving a minor (WA W CONV).

Any inmate fitting this criterion will have the following annotation placed in the visiting program under the comments section: "this inmate was convicted of a sex offense involving a minor."

Any inmate identified as having a Walsh Act assignment involving a minor will have his/her visits closely monitored. \*They will be instructed to sit as near the Visiting Room Officer as possible so the visit can be monitored as closely as possible.

#### 5. CONTRABAND:

- a. Each visitor shall be required to sign a copy of the Notification of Visitor (Attachment B of Programs Statement 5267.09) when the visitor arrives at the institution acknowledging awareness and understanding of the possible penalties for violation of the policy and/or controlling statues. When this form is signed, he/she also acknowledges having read, understood and agreed to the statement of Visiting Regulations, Attachment 2, previously mailed to him/her by the inmate. Should the visitor not have received or read this statement, he/she will be given the opportunity to do so prior to the visit.
- b. <u>Narcotics Detection Screening</u>: All inmate visitors entering the institution will be randomly screened for the presence of narcotic residue on their person. This test will be conducted using the drug screening machine. Procedures for narcotics screening are detailed in the respective Program Statement and Institution Supplement entitled Ion Spectrometry Device Program.
- c. Any effort to circumvent or evade these visiting regulations will result in termination of visiting privileges.

## VISITING REGULATIONS

**IDENTIFICATION:** Positive picture identification of visitors will be required. The best forms of identification are Driver's License and Social Security Card; however, a state picture I.D. is acceptable. (Requirement #14)

#### VISITING HOURS:

\*FCI visiting hours are 8:30 a.m. to 3:00 p.m. Saturday, Sunday, Monday and on Federal holidays. \*FPC visiting hours are 8:30 a.m. to 3:00 p.m. Saturday, Sunday, Monday and on Federal holidays.

**REGULATION:** The right to make future visits may be denied to anyone who tries to circumvent or evade regulations. The introduction of or an attempt to introduce contraband into a Federal Penal Institution is a violation of Sections 1791 and 3571, Title 18 of the U.S. Code Attorney General's Regulations, and provides a penalty of not more than 20 years imprisonment and/or \$250,000.00 fine, or both. Contraband is defined as follows: Any item given to or left where accessible to inmates (such as firearms, destructive devices, ammunition, other objects designed to be used as a weapon, narcotics, controlled substances, alcohol, money, and other items) for which specific approval of this institution has not been obtained.

<u>APPROPRIATE DRESS</u>: In consideration of the family atmosphere in the visiting room and the need for visits to occur without disruptions, we ask the visitors dress be in good taste and conduct must conform to institution policy. No see-through or provocative garments will be allowed and all dresses will be worn in good taste (i.e., no plunging necklines, the hems will be at least knee length, and footwear is required at all times.) (Shorts may be worn; however, they cannot be higher than 1 inch above the knee.) (Requirement #13)

## THE USE OF CAMERAS OR RECORDING EQUIPMENT WITHOUT WRITTEN CONSENT OF THE Warden IS STRICTLY PROHIBITED. No written messages may be exchanged during a visit. THE USE OF CELLULAR COMMUNICATIONS IS STRICTLY PROHIBITED. (Portable telephones, etc.)

**LOCATION:** The Federal Correctional Institution in Talladega, Alabama, is located approximately 50 miles east of Birmingham, Alabama, and 100 miles west of Atlanta, Georgia. It is situated on the west side of the City of Talladega, Alabama, on County Road 42, Renfroe Road. Cooperation with the above instructions is necessary by both the inmate and his visitor(s) in order that visiting may be fully utilized for the benefit and enjoyment of all concerned.

## **RESOURCES:**

- 1. **Transportation:** The bus depot is approximately thirty miles from the institution. Taxi service is available. There is no institution shuttle service.
- 2. <u>Motels:</u> There are three motels available in Talladega, all of which are located approximately five miles from the institution.
- 3. <u>Social Agencies:</u> There are no social agencies able to provide services in case of emergency situations visitors may encounter.

No help is available for financial needs that may arise, such as loss of money or automobile repair.

- 4. <u>Visitor Responsibility:</u> All inmates are again reminded to inform their families they must be prepared to meet all financial obligations incurred while in our community.
- 5. **Institution Addresses and Phone Numbers:** (Requirement #11)
